In view of the upcoming ITF 12<sup>th</sup> Junior & 7<sup>th</sup> Veterans Taekwon Do World Championship in September 2016 in Italy, I remind you that the following countries are subject to visa obligations to participate:

Afghanistan, Algeria, Angola, Armenia, Azerbaijan, Bahrain, Bangladesh, Belarus, Belize, Benin, Bhutan, Bolivia, Botswana, Burkina Faso, Burundi, Cambodia, Cameroon, Cape Verde, Central Africa, Chad, China, Colombia, Comoro Islands, Congo, Congo (Democratic Republic of), Cuba, Djibouti, Dominican (Republic), Ecuador, Egypt, Equatorial Guinea, Eritrea, Ethiopia, Fiji, Gabon, Gambia, Georgia, Ghana, Guinea, Guinea Bissau, Guyana, Haiti, India, Indonesia, Iran, Iraq, Ivory Coast, Jamaica, Jordan, Kazakhstan, Kenya, Kiribati, Kosovo, Kuwait, Kyrgyzstan, Laos, Lebanon, Lesotho, Liberia, Libya, Madagascar, Malawi, Maldives, Mali, Marshall Islands, Mauritania, Micronesia, Mongolia, Morocco, Mozambique, Myanmar, Namibia, Nauru, Nepal, Niger, Nigeria, North Korea, Oman, Pakistan, Palau, Palestinian National Authority, Papua-New Guinea, Peru, the Philippines, Qatar, Russia, Rwanda, Solomon, Sao Tome and Principe, Saudi Arabia, Senegal, Sierra Leone, Somalia, South Africa, Sri Lanka, Sudan, Suriname, Swaziland, Syria, Tajikistan, Tanzania, Thailand, Togo, Tonga, Tunisia, Turkey, Turkmenistan, Tuvalu, Uganda, Ukraine, Uzbekistan, Vietnam, Yemen, Zambia, Zimbabwe.

These countries need to be in possession of the following documents/forms:

- Entry visa application form
- Recent passport-size photograph
- Valid travel document whose expiry date is three months longer than that of the visa requested
- Return ticket (or booking) or evidence that the applicant has their own means of transport
- Proof that the applicant has sufficient means of subsistence as required by the Directive of the Ministry of the Interior dated 1st March 2000 ( View )
- Health insurance covering a minimum of €30,000 for emergency hospitalisation and repatriation expenses, valid throughout the Schengen area
- Invitation letter from either CONI, the relevant Italian Sports Federation or the organising body that certifies the person concerned is attending the event and requests the issue of the visa

- Proof that the applicant has accommodation in Italy: hotel booking, declaration of hospitality, declaration of payment of accommodation costs by the hosting Federation or Sport discipline etc.

We will be able to send the invitation after receiving your account payment for the accommodation fee.
